INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information that you (including your staff and contractors) provide by filling in forms on our site www.amlcc.co.uk (**our site**). This includes information provided at the time of subscribing to our service, posting material in the course of using our services or requesting further services. We may also ask you for information if you report a problem with our site or services.
- If you contact us, we may keep a record of that correspondence.
- We may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- Details of transactions you (including your staff and contractors) carry out through our site and of the fulfilment of your orders.
- Details of your (including your staff and contractors) visits to our site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

IP ADDRESSES

We may collect information about your (including your staff and contractors) computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to our advertisers. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.

COOKIES

WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). DISCLOSURE OF YOUR INFORMATION

We may disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets.
- If Anti Money Laundering Compliance Company Limited or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms and conditions (<https://www.amlcc.co.uk/amlcc/policy/AMLCCtandc.pdf>) and other agreements; or to protect the rights, property, or safety of Anti Money Laundering Compliance Company Limited our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.
